Extension of Town Hall Road Fire Hydrant: Supervisor Jason Sjostrom: At the cemetery meeting on April 25, 2016, the committee discussed moving the fire hydrant up to the end of Town Hall Road. No decision was made. No motion made.

Ventures Unlimited – Seasonal Park Cleaning Contract: Contract prices were the same as last year. Supervisor Hoff made a motion to accept the 2016 contract. Supervisor Sjostrom 2nd the motion. All in favor. 5 yes,0 no. motion carried.

Prairie Lane & Lenroot Lane: Reconsider Change to Town Road. Supervisor Hoff made a motion to remove this item from TABLE. Supervisor Sjostrom 2nd the motion. All in favor. 5 yes, 0 no. Motion carried. The Board discussed the pros and cons for the township. If the town did take over these roads, the Road

Ordinance would have to be amended, which some were not in favor of amending. Subdivision Deeds would have to be redone, to add stipulations defining who pays for the costs of further road development [blacktopping]. Most felt the residents on these roads bought their properties knowing the roads would be their responsibility to maintain. Supervisor Kariainen made a motion that the town **does not** take over these roads. Supervisor Hoff 2nd the motion. All in favor. 4 yes [Supervisors Hoff, Jason Sjostrom, Kariainen, Sjostrom] 1 no [Chairman Christians.] Motion carried.

Silverthorn Park Ball Field Repairs: Two quotes were received from Dairyland Fence Company. Option 1.
\$3,600.00. Replace approximately 46 LF of 10' tall chain link fence with new and dispose of old fence, replace brace rail on backstop and replace approximately 50 LF of 10' tall chain link fabric on backstop. Option 2.
\$2,570.00. Provide general repairs to 1,120 LF of 4" tall outfield fence to include tying fabric to top rail, bending back posts level, replacing

1 each corner post, replacing 20 LF of rail, and attaching new fittings to broken weld joints. Supervisor Jason Sjostrom made a motion to accept **Option 1 for \$3,600.00.** Supervisor Sjostrom 2nd the motion. All in favor. 4 yes [Supervisors Jason Sjostrom, Hoff, Karianen, Sjostrom] 1 no [Chairman Christians] Motion carried.
