PUBLIC INPUT: Andy Eaton re: Eaton Road Speed Limit. The existing speed limit is 45 mph. Mr. Eaton requested a reduced speed limit to 25 mph. There are many families and children in the area and they are concerned for their welfare. To lower the speed limit it would take a lengthy speed study, car count and enforcement. The township has posted a Dead End sign, which Mr. Eaton said was very much appreciated and he understood the reasoning for not changing the speed limit.

Bill Wilcox: Noted a sign for the ATV Route was needed on Tanning Point Road. Paul will place a post for their use in that area.

OLD BUSINESS: Norway Point road. Chairman Christians went to the site and determined that there was no place for a culvert on town property. Home owner would have to decide if he wants to put a culvert on his own property. **Operator License:** It has been determined in the process of issuing Operator license that background checks are open to the public. **Walport Project:** Chairman Christians determined that the township could give 100 yards of gravel on the township portion of road to be fixed. **Nelson Lake Dam Park:** The MOU is all set with the county.

All in favor. 4 yes, 0 no. Motion carried. It was agreed by all that Supervisor Jack Sjostrom is the most senior supervisor on the board.
