**OLD BUSINESS:** The toilet @Gerlach's Landing will be installed as soon as the road bans are off. Nelson Lake Park Shelter Project-Chairman Christians has been in contact with Tom Foss and Mark Boyle, they will submit a price list of their cost to do this project.

**ZONING: Brad & Lori Nidersson-Change of Zone District Application.** Supervisor Sjostrom made a motion to approve this application. Supervisor Bandow 2<sup>nd</sup> the motion All in favor. 5 yes, 0 no. Motion carried. The board was curious as to why it was allowed to be developed with split zoning. They would like a response from the Zoning Administration.

**VENTURES UNLIMITED PARK CLEANING CONTRACT:** Supervisor Jason Sjostrom made a motion to approve the contract for Silverthorn Park and Eytcheson Park. Supervisor Kariainen 2<sup>nd</sup> the motion All in favor. 5 yes, 0 no. Motion carried.

**NELSON LAKE PARK SIGN:** Chairman Christians informed the board the cost of the sign should be \$280.00,plus \$30.00 for UV protection. Final total of \$310.00. Supervisor Jack Sjostrom made a motion to approve the park sign. Chairman Christians 2<sup>nd</sup> the motion all in favor. 5 yes, 0 no. Motion carried.

**TOWN OF LENROOT SEELEY RIVERSIDE CEMETERY:** The spring cemetery meeting has been set for April 28<sup>th</sup>, 2019, @6:00 pm.

**ROADS AND BRIDGES REPORT:** Roads in good condition. Road Manager Paul Kuczenski had an accident at home and has 7 broken ribs and a punctured lung. He will be off work for a few weeks. The board agreed that an emergency part time replacement would be needed on occasion. At this time Peter Sjostrom will continue to help with the snow plowing. Supervisor Jason Sjostrom has a CDL license and agreed to help out part time with truck driving. The wage for part time workers is \$14.00 per hour. The chairman will also contact the town of Hayward and Town of Spider Lake for any help needed if Eric is unavailable. As this will be an emergency issue, the board at the 2019 Annual Meeting will present documentation to allow that in the future, a chairman or supervisor may be employed by the town to help out in a like situation. It was also noted that when Paul returns to work he must have a doctors release form to present to the town board.
