PUBLIC INPUT: Dennis Erickson spoke in regard to Todd's Redi Mix gravel pit issue. He feels there has been overdevelopment of gravel pits in the township. All zoning issues should be reviewed to consider the health, safety, topography, water pollution, flood plain, traffic movement, harmful noise, dust, smoke and other factors. Years ago, when he opened up a wood working shop he had to answer to the town board if his shop would affect his neighbors, which it did not. He would like others to be held to the same standard. Todd's Redi Mix was supposed to be summer crushing, but it is still going on now in November. He feels the town should be able to do something about this issue. Chairman Christians noted that any changes would have to wait until the next time Todd's Redi Mix applies for a renewal of his gravel pit. At that time the Board will take a more in depth look at the situation.

ARPA Update: Supervisor Steven Kariainen The town will receive \$135,000.00, so far the town has received one half of that total. The township has committed \$10,000.00 toward the Norvado project. Another item that qualifies is a bonus for essential workers. Such as election workers. The town board will determine said bonus.
