APPROVAL OF COMBINED CLERK & TREASURER REPORTS: Supervisor Bandow made a motion to approve the August 15th, 2022 report. Chairman Christians. 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

OLD BUSINESS: Tagalder Bridge Project progressing.

ZONING: Mark & Debra Bruschuk – Town Approval Application. Building a new home. Supervisor Jack Sjostrom made a motion to approve the application. Supervisor Poppe 2nd the motion. All in favor. 5 yes, 0 no. Motion carried.

Clerk Carol Stone recused herself from the Board during this discussion re: Larry & Kim Verissimo – Conditional Use Application. Mr. Verissimo is hoping to sell the property to a party who wishes to create another KOA Kampground across from the existing Kampground on Hwy 63. Mr. Verissimo stated that if this Conditional Use Application is denied, his buyer does not want the property. The new KOA site would be across from the existing KOA on the Phipps Road side, at the previous owned Hans Rang Property. This property abuts on several neighbors properties.

A KOA Representative spoke via telephone. Saying it is not their intention to disrupt any resident's life. She feels this campground will be peaceful and quite, although that cannot be guaranteed. She also stated no unit would be built within 120 feet of property lines. She felt it would be good for the area adding another KOA.

Fred Goold of the Town of Lenroot Comprehensive Plan Board stated his concerns regarding the existing campsite has 400 camp units and by adding 84 more this would make a larger development, and another KOA would not really enhance anything for the township.

Two (2) Objection Letters were received. Two (2) neighboring residents attended the meeting and explained their objection to the camp ground which were as follows:

- 1. 84 units at full capacity amounts to 168 persons creating a small city right on our doorstep.
- 2. Noise factor. All day and half the night
- 3. Decrease in property value
- 4. Affect the groups of wildlife and their bedding grounds.
- 5. Safety factors, camp fires, smoke.
- 6. Loss of a quiet, private country home.

After much discussion the board decided to Table the application until the October meeting.
